Bylaw 2021-05: Municipal Development Plan (MDP) Amendment is being proposed in consideration of Council's proposed Strategic Plan to streamline development and growth in our community. The MDP is a long-range planning policy adopted by Bylaw and sets a clear path for how the Town of St. Paul will grow into the future. It contains principles, goals and objectives to ensure that the community vision is realized.
